



## **PARTNERSHIP FOR ECONOMIC POLICY (PEP)**

### **INTELLECTUAL PROPERTY STATEMENT**

Final reports from PEP-supported projects should be solely the work of the researchers (and signed only by them) with resource persons playing a purely advisory role. As ruled by the *PEP mentorship agreement*, we encourage resource persons to participate as co-authors in the preparation of subsequent publications (working papers, journal articles, etc.), where the resource person has already provided or can make a substantive contribution that increases the relevance/quality of the research for domestic policy making, the likelihood of it being published and/or the reputation of the journal in which it is published. If any members of the team have not provided a substantive contribution, their names may be removed from these subsequent publications with the written agreement (email to TRG director) of the members in question by the time the revised final report and the 'publication strategy' are submitted.

One of PEP's main program objectives is to see that knowledge generated by the project is widely disseminated and used for development. Researchers have the right to publish, upon proper acknowledgment of the support provided by PEP, the results of the project, or any other information prepared or produced as a result of this grant (such as a presentation at a conference), and are not required to obtain the consent of PEP to do so. Researchers are requested to inform PEP of any related publications and activities. Researchers will recognize the support of PEP by including, in all related publications, the following acknowledgement:

Unless the researchers explicitly object, PEP will systematically publish and distribute outcomes and related information from PEP-supported projects – including but not limited to writings, photos and video recordings – on its website and through other communication channels (including social media, annual reports, newsletters, reports to donors, etc.). If the researchers object to the publication or distribution of the results or information, PEP shall consider the reasons given for the objection before making a final decision.

To assist in PEP’s own communication and reporting activities, researchers shall provide PEP and, if appropriate, other Collaborating Institution(s) with one soft electronic copy of any publication (and the underlying data) of the results or of any other information prepared or produced as a result of a PEP-supported project.
