Women, Children and Climate Change

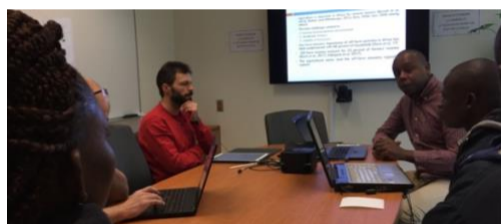
2018 PEP Policy Forum. Bangalore, India - June 13.

One in five PEP projects has a paper published in a peer-reviewed journal

In 2017, papers from 12 PEP-supported projects were published or accepted for publication in international peer-reviewed journals. Five of the accepted papers come from projects conducted in low-income economies, fragile or conflict states. Overall, 1 in 5 projects supported by PEP since 2013 has been published in a scientific journal, and at least a third of these publications were in high-impact journals (that reject up to 95% of submissions). Policy Analysis on Growth & Employment – 2016-2020

PAGE 2016-2020 is currently supporting 29 projects in 22 developing countries, including 15 low-income economies and fragile or conflict states. New features of this second PAGE initiative include [distance \(online\) training](#) for all members of shortlisted applicant teams, mentoring support in [policy engagement](#), and an [institutionalization project](#) conceptualized through the Macro-Micro Policy Modelling TRG.

Initial findings from the first institutionalization project supported by PEP under the second phase of the PAGE initiative have recently been published. See “policy findings” below.

policy findings

PEP continually publishes the findings and outcomes of projects led by local research teams in developing countries who have been selected and supported through PEP's various research and capacity building initiatives.

Impact of fiscal consolidation on the Mongolian Economy

To avoid an economic crisis, the Mongolian government will receive USD 5.5 billion through an Extended Fund Facility agreement with the International Monetary Fund. However, the government must also cut its expenditures and increase taxes, a process known as “fiscal consolidation”. As the country's economy is highly reliant on the mining sector, a team of local PEP researchers evaluated how fiscal consolidation is likely to impact the Mongolian economy under different international commodity price conditions. Their findings indicate that fiscal consolidation when international commodity prices are low could result in significantly decreased production and GDP. [Download PEP Policy Brief 175](#)

During the workshop, the team presented the computable general equilibrium (CGE) modelling techniques they are using as well as the application, possibilities and advantages of using CGE models for policy analysis in other areas.
